Bids, regardless of the way they are delivered, must be delivered (received from the Contracting authority) no later than **10 April 2018, 15:00 h local time**. Bids that are not received within the prescribed deadline will not be included in the selection process.

The bidder independently determines the manner in which the bid is delivered and the risk of any loss or untimely delivery of the bid is borne by itself. If the envelope is not marked in accordance with the requirements of this Procurement Documentation, the Contracting authority shall not be liable for any loss or premature opening of the offer.

LANGUAGE OF THE OFFER:

The offer together with the accompanying documentation is produced and delivered in Croatian or English language and Latin script. The documentation issued by the competent authorities of other countries must be translated into Croatian or English (with the original version included) by the court interpreter. Bidders from abroad can bid in a different language (except Croatian and English) with the obligatory delivery and translation of documents into Croatian or English by a court interpreter.
